DTI is an IT company headquartered in a Historically Underutilized Business Zone (HUBZone), in the heart of Baltimore City. Delmock was nominated by Melissa "Lisa" Jenkins, for DTI's major efforts at Treasury which include software engineering and integration for middleware infrastructure and various enterprise business applications along with client-servers, web-based and virtual cloud computing architectures providing a forward-looking approach which transformed, modernized, and continuously improved service delivery and stakeholders' satisfaction.

DTI is also known at Treasury for infusing the *latest technologies, improved efficiencies and lower operational cost.* Their expertise includes cybersecurity, development, test, integration, implementation of custom developed infrastructure application & interfaces (SiteMinder, CA Directory (eTrust), WebSphere, JAVA, Oracle, Business Objects, SAP, and MQ Series); COTS software, 24x7x365 help desk spanning diverse geographic locations throughout United States.

DTI is on the front line of eliminating financial and educational disparities; hiring dozens of people from both Historically Black Colleges & Universities (HBCU), Veterans and HUBZone residents. They have been annually funding a program called FIRE (Finding Innovation, Research and Excellence) which they established at Morgan State University (MSU) several years ago to bring speakers from across Unites States to collaborate with the HBCU students. The DTI team's civic-mindedness has allowed them to garner various National awards from (National Mentor – Minority Access, Citizen of the Year - HUBZone Contractors National Council, Community Services Award for Outstanding Service - American Public Health Association (APHA) and *MSU's Award for Research Innovation and Engagement Award*).

As a team player, they continuously mentor other companies and support the small business offices. Whether it is HUBZone best-practice or championing certifications CMMI and ISO, they have proven to be a great business partner. They have support numerous small business outreach events (Meet Primes, Industry Days, ChallengeHER, etc.). In September they will once again be teaming with Treasury to increase the federal awards to HBCUs collaborating with HUBZones.
